

# Diversity: Challenges & Barriers

- Meta-cognitive skills (Savitz-Romer & Bouffard, 2012; Conley, 2005)
   "...the level of access students of color have to the kinds of "behaviors" and habits that are necessary for success in a college-prep program."
- Educator Perception (Valenzuela, 1999)
  "....perception of the community and of staff towards students of color regarding their potential for success. Students know when the adults around them believe they are capable or incapable."
- **Course Tracking** (Contreras, 2008)

  "...the greatest barrier in public education for students of color have been the selecting and sorting process built into our system."
