## Supplemental SNG Allocations for 2016-17

As was reported in the January 2017 SFA Partner, approximately \$2 million dollars in supplemental SNG funds were awarded to 60 institutions in December 2016. Award amounts were determined based upon the WSAC fair share SNG funding model.

Should additional SNG funds be available later this year, our plans are to distribute them through the fair share model as well. If your institution will be deobligating 2016-17 SNG funding, please notify Carissa Glassburn as far in advance as possible.

## Identifying and Reviewing Conflicting Information for State Aid Eligibility

Aid administrators should have received an email from Carissa Glassburn on March 15, with comments related to the Department of Education's August 2016 guidance on resolution of conflicting student information. The text of Carissa's message is repeated here to alert aid administrators regarding WSAC's perspective and the potential for adjustments to a student's state aid eligibility as a result of the recent federal information:

“On August 3, 2016, the U.S. Department of Education provided guidance to institutions on the subject “2017-2018 Early FAFSA—Identification and Resolution of Conflicting Information.” In the department's guidance, it indicates that during the review of 2017-18 FAFSA ISIRs, cases may be identified where institutions must review and update student 2016-17 FAFSA ISIR information. The required federal resolutions could result in changes in 2016-17 federal financial aid awarded which could in turn result in repayment of 2016-17 federal financial aid if it had been previously disbursed.

“Related to this, we received a recent inquiry that we want to share with all institutions.

**“Q. Does WSAC require that state aid eligibility be reviewed and possibly be revised and/or repaid in situations where this required resolution has been completed?”**

**“A. Yes. This required resolution could change a student's need for state programs such as SNG, CBS, Passport to College, and State Work Study and/or the median family income (MFI) amounts for SNG and CBS eligibility. If so, adjustments must be made to a student's current year state financial aid. If this review results in a repayment in state award amounts, those repayments should be handled in the manner described in the SFA program manuals.**


“Although this response is specific to the situations identified on ISIRS by the FAFSA federal processor, institutions may (but are not required to) implement a review of the state aid eligibility for students who file both 2016-17 and 2017-18 WASFAs. The WASFA process will not, however, identify specific situations where resolution of data between the two years is required.”

## Summer 2017 Guidance for Awarding of CBS and SNG

All eligible CBS Scholars must be awarded SNG during the summer 2017.

SNG and CBS maximum award amounts for summer 2017, are to be based on the award chart for the 2016-17 year (page 29 of 2016-17 SNG and CBS Program Manual). This will be the same whether the summer award is considered as Summer 2 (trailer) or as Summer 1 (leader) at your institution. 

- Additional information and options when awarding SNG to eligible CBS Scholars in (2016-17) Summer 2.
  - Award all eligible CBS Scholars, who have complete files with your school by June 1, with Summer 2 CBS and SNG funds from your 2016-17 SNG allocation.
  - If you have CBS Scholars whose files are completed between June 1 and August 1, who enroll in your summer term, contact WSAC for payment instructions if you don't have remaining SNG 2016-17 funds to award.
  - Be sure your 2016-17 allocation is fully spent and reported to WSAC by July 7, on your final Interim Report.
  - No Summer 2 CBS or SNG awards should be made to students whose files are complete after August 1. Contact WSAC if you later need to adjust your final Interim Report.
- Additional information and options when awarding SNG to eligible CBS Scholars in (2017-18) Summer 1.
  - Award all eligible CBS Scholars Summer 1 SNG awards, and charge it to your institution's 2017-18 SNG allocation when available.
- Additional information when awarding SNG to non-eligible CBS Scholars in either (2016-17) Summer 2 or (2017-18) Summer 1.
  - If your approved institutional awarding policies allow, you may make Summer 1 awards and charge them to your institution's SNG allocation.
  - Remember to use the 2016-17 SNG award chart though for determining the summer SNG award amount.
- If eligible for SNG funding, but no award is made, report as unserved.

## SNG and Passport to College Self-Help Calculation 2017-18

The self-help calculation gets updated each year that there is a change to the state minimum wage. With an increase to the state minimum wage as of January 1, 2017, there will be an update to this section of the 2017-18 SNG and CBS Manual. The self-help requirement does not, however, apply to eligible CBS Scholars.

The information that follows should be used in 2017-18 awarding. Changes from the 2016-17 year manual are shown in red below. This same self-help requirement applies to Passport to College recipients if they were CBS Scholars but were not eligible to receive CBS funding due to their family income.

## ***What is the self-help requirement for all other SNG students who are non-eligible CBS Scholars?***

**The self-help contribution required for all other State Need Grant recipients is equal to the lesser of:**

- 12 percent of a student's Cost of Attendance if the institution is using an "at home" Cost of Attendance for a student. In most cases this will mean using a "living with parent" budget for the student.
- 25 percent of the student's Cost of Attendance if the student's total annual cost is \$16,092 or less.
- \$4,023 if the student's Cost of Attendance is greater than \$16,092.

**Note:** Institutions may require higher self-help requirements than any of these items shown above (except for eligible CBS Scholars) if this is covered in their institutional gift equity policies submitted to WSAC for review and approval.

**Note:** The \$4,023 self-help contribution amount has been determined by WSAC. This assumes that a student could have earnings of at least the value of a minimum wage job (minus Social Security and Medicare taxes) for 12 hours per week for 33 weeks during the year.

The 2017 minimum wage is \$11.00 per hour (minus \$0.84 per hour in taxes) equals net wages of \$10.16 per hour x 12 x 33 = \$4,023.

## **Successful SNG and CBS Training Webinars for Financial Aid Administrators**

Approximately 90 financial aid administrators participated in the SNG, CBS, and Passport to College training webinars on March 6 & 7. Feedback from survey participants showed a high degree of value for both content and method of communication. According to one of the participants:

*I loved that WSAC put together these training sessions! It was great to get an update on how WSAC goals are going and a refresher on eligibility requirements. I definitely think it is important to get this refresher after you have been working in these programs for one year or more because you understand the terminology way better than when you first start learning it.*

Of survey responders, 95 percent also indicated that they would be interested in attending future SFA webinar training opportunities. Our thought at this time is to offer similar training each year. Let us know if you have particular topics you would like us to consider adding.

We are no longer using the billing services of Heartland ECSI and are in transition to our new servicer, University Accounting Service (UAS). Please do not refer students to Heartland ECSI.

Additional information will be communicated to all debtors directly regarding our new service and instructions with how to make payments beginning May 1, 2017. We will share the student contact information for UAS in the coming weeks.

## State Work Study Information

### 2016-17 State Work Study (SWS) Update and Reminders

- **SWS Expenditures**

Thank you to institutions for your diligent work to ensure that SWS opportunities are maximized by eligible students. Current 2016-17 expenditures are on track for 100 percent utilization. WSAC was able to provide supplemental SWS funding during the February Survey Round to institutions indicating the capacity for additional student earnings. Please continue to carefully monitor your 2016-17 expenditures so that funds that may go unearned at your institution can be transferred in a timely fashion to institutions in need of additional SWS resources. SWS intends to conduct one more 2016-17 survey in May.

- **WSASEA Spring Conference and WSAC Sponsorship**

WSAC will sponsor new SWS Administrators' first-time attendance at the upcoming Washington State Association of Student Employment Administrators (WSASEA) spring conference, a value of \$240! The conference takes place on May 1 - 3, 2017 at Rainbow Lodge in North Bend.

This year's topic is "Working Together to Improve Our Community" and agenda items include a WSAC/SWS update, a Federal update with the US Department of Education, and a sector breakout session.
