Week 5 Legislative Recap February 9 - 13, 2015

Proposals Requiring a Minimum GPA for State Need Grant Eligibility

Senate SNG Proposal

A Senate Higher Education Committee hearing was held on <u>SB 5547</u> (Feb. 12). The bill, sponsored by Chair Bailey, would require State Need Grant recipients to maintain a 2.5 GPA to be eligible for renewal of their State Need Grant. At the hearing, Rachelle Sharpe, WSAC Senior Director of Financial Aid and Student Services, outlined State Need Grant academic progress standards:

- There is a term-by-term evaluation of progress focused on credit completion.
- Institutions must have a GPA policy in place and these vary by institution.
- This proposal would impact over 7,000 students who have a GPA between 2.0 and 2.5.

A number of higher education stakeholders testified in opposition to the bill. Paul Francis of the Council of Presidents (COP) stated that the purpose of the State Need Grant is to assist low-income students with completing a degree. Francis noted that students need help at times and said the proposal may have unintended negative consequences such as reducing student enrollment in more challenging courses, including STEM.

Heather Heffelmire, of the Washington Student Association, spoke in opposition, stating that it is not fair to expect students coming from poorly-funded schools to compete with those from well-funded public or private schools when they begin their postsecondary programs. Scott Copeland, Student Services Policy Associate at the State Board for Community and Technical Colleges, noted the proposal could increase time to graduation. Copeland echoed the concern that this proposal may incentivize students to take less challenging courses.

Others testifying in opposition included Steffini Hedstrom, WSA; Jordan Martin, WSA, Associated Students of Eastern WA; Paul Bell, Office of Student Legislative Affairs at Bellevue College, State Legislative Liaison. Juliette Schindler Kelly of the College Success Foundation also testified in opposition outlining the impact on College Bound students.

House SNG Proposal

Representative Hargrove's bill, <u>HB 1767</u>, that adds a minimum 2.0 grade point average for continued eligibility for the State Need Grant was heard in the House Higher Education Committee on February 13. Rachelle Sharpe of WSAC, provided informational testimony noting that Washington has stricter academic progress requirements than the federal standards because the state requires credit accumulation to be monitored each term rather than on an annual basis. Sharpe said that institutions are required to have a GPA policy in place to monitor progress, with the exceptions of Evergreen State College, Antioch University and Western Governor's University (these schools do not use grades and have alternative policies in place). Scott Copeland of SBCTC stated that in addition to monitoring by federal and state standards for financial aid purposes, accreditation standards at community and technical colleges require all students to retain a 2.0 GPA.

Paul Francis, COP, testified in opposition to the proposal noting that the SNG is a successful program and the problem is lack of funding, not design. Francis outlined findings from a recent study that found a 25% reduction in the State Need Grant was associated with a 2.2% decrease in re-enrollment for the following fall quarter; and an 8.3 percent reduction in six-year graduation rates at Washington's public baccalaureate institutions.

Francis said that many SNG recipients are first-generation college students and need time to adjust before they can become academically successful. In addition it is necessary to give institutions flexibility to manage the variety of life circumstance that can cause students' grades to drop for a period. Francis stated that setting a uniform state-level requirement fails to recognize the distinct nature of Washington's higher education landscape.

Paul Bell, representing the Community and Technical College Student Association, provided testimony describing his initial difficulty when he first enrolled at Bellevue College in a Worker Retraining program. With continued access to the State Need Grant during this time, Bell stated that he was able to persist, adjusted to the rigors of college, and became a student leader.

Proposals to Dedicate Funding to Education

The House and Senate Higher Education Committees heard companion proposals to provide basic education funding to support basic education for adults at community and technical colleges.in <u>HB 1705</u> is sponsored by Representative Haler and <u>SB 5619</u> is sponsored by Senator Bailey.

In testimony, John Kerr of the State Board for Community and Technical Colleges noted that Adult Basic Education (ABE) only generates \$25 in tuition and that dedicated funding is needed. Nick Lutes of the State Board for Community and Technical Colleges commented that the proposal would create a caseload associated with the ABE population to provide stable funding for the program. Lutes emphasized the differences between funding ABE, K-12 and other postsecondary education programs. ABE state funding is about \$3,000 per student compared to \$6,000 for K-12 students, and \$6,000 to \$18,000 when combined with tuition for postsecondary students.

Senator Baumgartner, Vice Chair for the Senate Higher Education Committee, has sponsored a S286. This proposal would dedicate one penny of existing sales tax to higher education. Baumgartner noted that higher education needs a dedicated revenue stream. Baumgartner noted that higher education funding is discretionary and recently the burden of paying for higher education has shifted to students, causing them to take on higher levels of debt. Testifying in favor were Steve DuPont, Central Washington University; Alicia Kinne-Clawson, Eastern Washington University; Trevor Justin, Associated Students of CWU, WA Student Association.

Information for High-Achieving, Low Income Students

<u>HB 1812</u> is a proposal sponsored by House Higher Education Committee Chair, Representative Hansen. It would create an informational program to increase applications from high-achieving low-income high school students to selective institutions of higher education.

Testifying in favor the proposal, Paul Francis of COP noted that in 2013 a student from the highest income quartile family had a 77 percent chance of obtaining a baccalaureate degree by age 24, while students from the lowest income quartile had a 9.1 percent chance. Not every student needs to earn a bachelor's degree, but all should be given the opportunity, if interested, to earn some postsecondary credential. This bill would be one more tool in the existing toolkit.

Postsecondary Education for Inmates

The House Higher Education committee heard HB 1704, sponsored by Representative Pettigrew. The bill would permit the Department of Corrections to expand postsecondary options for inmates beyond vocational programs to include degree options. The proposal does not include state funding, but third parties could support postsecondary education for this purpose. Those testifying outlined how increasing education has been shown to reduce recidivism through increased employment opportunities.

Aligning with Federal Requirements to Receive Veterans Education Benefits

The Governor-request proposal, <u>HB 1825</u> is sponsored by Representative Kilduff. It would broaden the definition of resident student to comply with federal requirements established by the federal Veterans Access, Choice, and Accountability Act (Choice Act). Jim Baumgart of the Governor's Office noted that approximately \$62 million worth of veterans benefits provided to our state's colleges and universities are at risk unless we make this correction.

Heather Heffelmire (WSA), a veteran and a third-year college student at Western Washington University, testified in strong support. She said that if the bill is not passed, all her hard work in the Navy and at college will have gone to waste. Maddy Thompson, WSAC Director of Policy and Government Relations, spoke in support of the substitute bill. The substitute adds an emergency clause as the federal requirements will come into effect on July 1. The companion substitute SB 5355 passed out of the Senate Higher Education Committee on February 13 and has been referred to Ways and Means.

Executive Action

The House Higher Education committee passed <u>SHB 1238</u>. The bill requires WSAC to conduct a study of affordability and tuition. WSAC is directed to include proposed parameters for tuition as an appropriate share of median household and family incomes. The report would be due to the Legislature by December 15, 2016.

Cutoff

February 20 is the first cutoff for bills to be passed out of policy committees. All bills that do not pass out will not move ahead this session unless they are deemed "necessary to implement the budget."
