## **First Cutoff**

Friday February 20 was the first cutoff for bills to pass out of policy committees. This Friday, February 27 is the first fiscal cutoff.

## **Dual Credit and Vets Residency Proposals are Still Alive**

Dual Credit and Vets Residency bills made it past the first cutoff. As of February 25, the Senate proposal related to dual credit, <u>SSB 5080</u> (Dammeier) has not yet been scheduled for a hearing in Ways and Means. The House proposal, requested by the Office of Financial Management, <u>SHB 1546</u> (Reykdal), was heard in Appropriations on February 24.

Vets residency definition proposals <u>SHB 1825</u> (Kilduff) and <u>SSB 5355</u> (Bailey) have both been heard in the fiscal committee. <u>SSB 5355</u> is scheduled for Executive Session on February 26.
