Sponsor/Exhibitor Guidelines Form

Washington Student Achievement Council (WSAC) is responsible for planning the 2015 Pave the Way Conference. These guidelines ensure that there is no appearance of any conflicts of interest between WSAC and conference sponsors and exhibitors.

All Pave the Way 2015 Sponsors and Exhibitors must agree to these guidelines:

- 1. Gifts or giveaways must be of nominal value or approved by WSAC staff.
- 2. Allowable prizes for drawings are items that the Sponsor or Exhibitor normally market.
- **3.** Exhibitors may sell their products and services. The sales are limited to the products and services that are normally marketed by the Sponsor or Exhibitor.
- 4. Exhibitors may not sell their products and services at Pave the Way breakout sessions.
- 5. Sponsors and Exhibitors will be acknowledged as stated on the conference Sponsor/Exhibitor Sign-up form.
- 6. Sponsors and Exhibitors understand that there is no obligation between any participating WSAC program and the Sponsors or Exhibitors to purchase products or services at the conference or in the future.
- 7. The Exhibitor assumes responsibility and agrees to indemnify and defend the Washington Student Achievement Council (WSAC) and The Greater Tacoma Convention Center (GTCTC) and their respective employees and agents against any claims, or expenses (including damage or accident) arising out of the use of the exhibition premises.
