2019-21 Strategic Action Plan - Agency Priorities

Rachelle Sharpe, Deputy Executive Director Marc Webster, Director of External Affairs

Members reviewed several proposals organized in the key challenge areas. The proposals (listed below) are an effort for the agency to make meaningful progress toward the state goals. Members reviewed the proposal details, considered the potential costs and associated outcomes, and provided input as to how

the proposals might evolve for potential inclusion in the Governor's budget and the 2019 Strategic Action Plan report.

- Close Opportunity Gaps
 - o Support for College Bound Scholars: \$400,000/year
 - Expand FAFSA/WASFA filing efforts: \$225,000/year
 - o Address teacher shortages: \$1,000,000/year
- Support for Returning Adults
 - o Enrollment navigation supports: \$500,000/year
 - o Provide institutions with technical assistance: \$500,000/year
 - Expand child care funding: \$3,000,000/year
- Improve Affordability
 - Maintain the state's commitment of fully funding Need Grant: \$60,000,000 for year 1/ and \$40,000,000 for Year 2.
 - Support middle-income students with grant aid: \$47 million/year
 - o Expand State Work Study: \$5,000,000/year
 - Offer a Savings Match Incentive: \$500,000.
- Engage Regional Leaders
 - o Innovation Fund: \$5,000,000

Council members largely supported the proposals and discussed the proposals could be strengthened through intentional alignment with sector partners. Members asked WSAC staff to provide further detail on the regional innovation grant proposal in a future phone meeting.

Council members requested to see sector partners' proposals and asked that WSAC work together with its sector partners to align and strengthen the requests. WSAC staff will provide further detail on the regional innovation grant proposal in a future phone meeting.

A motion was made to approve the proposals associated with three of four challenge areas. A phone call will be scheduled within the next two weeks to finalize the "Engage Regional Leaders" innovation fund. Motion seconded.

Public Comment:

Paul Bell asked questions regarding childcare funding and help for students with disabilities.

Breanne Boggs, Office of Financial Management, said that fully funding SNG aligns well with the Governor's strategic agenda and the child care grants and regional innovation grants fit well with Career Connect Washington.

Before final approval of WSAC's budget priorities package, members explored how one such priority, the regional innovation grant, might be effectively implemented. In order to identify and reach the desired outcomes for this initiative, members agreed that further collaboration with a variety of stakeholders, as well as coordination with parallel programs and initiatives (such as Career Connect Washington), will be necessary.

Motion was made to pass the Engage Regional Leaders, innovation fund of \$5,000,000. Motion seconded.
