#### Increasing the Number of Students Completing Financial Aid Applications

#### Goals

- To make progress towards achieving WSAC's Roadmap goal for 70% of the state's adults to earn a college credential
- To increase the number of Washingtonians going to college and earning credentials
- To increase the number of low income adults going to college with the support of financial aid
- To increase the number of people completing financial aid applications

### Purpose of the work group

Washington State has among the highest state investments in financial aid for low income students but one of the lowest financial aid application completion rates. A principle reason families fail to complete financial aid applications is that they need help filling out the applications.

The purpose of this work group is expand outreach to low income communities to inform them of opportunities to go to college with financial support, and to increase the number of people who can help low income families complete state and federal financial aid applications by providing training to college and university staff, who can in turn provide training to campus and community volunteers.
