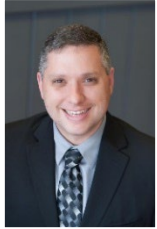

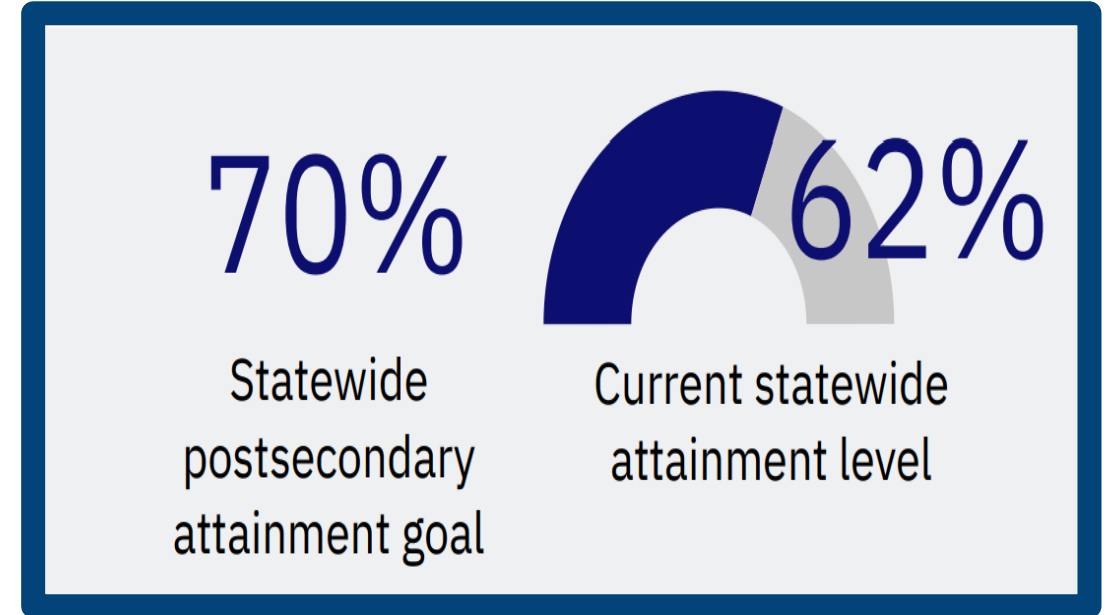

# Meeting the state's attainment goal

- Although Washington has higher attainment than many states, there are stark gaps for people of color, and the pandemic has exacerbated challenges.

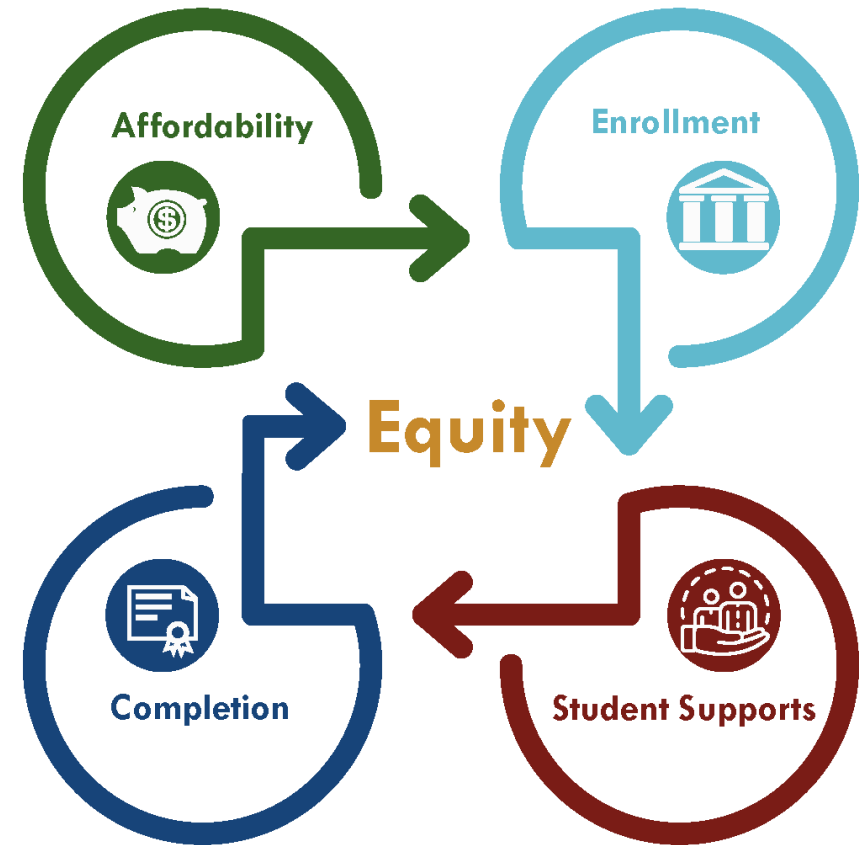

# Legislative Update



# 2022 Legislative Session

- **Session started Jan. 10, and ended on March 10, 2022**
  - Was a "short session" – second half of the biennium
  - Ended as scheduled – no special session
- **Governor signed budget on Tuesday, April 5, 2022**
  - **ESSB 5693** - 2021-2023 biennium supplemental operating appropriations.

# 2022 Session Update – Financial Aid Related Legislation

- **SHB 1642 – Washington National Guard grant program**
  - Graduate students added as eligible.
  - Changes the calculation of the maximum award value.
    - Does not reduce award based on other state and federal aid.
    - Likely not enough funding for all eligible.
      - Working with the National Guard on funding priorities.

# 2022 Session Update – Financial Aid Related Legislation

- **SHB 1736 – Establishing a state student loan program.**
  - Language states: WSAC must design a student loan program in consultation with the State Treasurer and State Investment Board, and submit a report by Dec. 2022, determining the feasibility.
    - WSAC may award loans beginning 2024-25.

*NOTE: There is a technical error related to the funding of this work that requires action by the 2023 Legislature.*

# 2022 Session Update – Financial Aid Related Legislation

- **2SHB 1835 – Creating outreach and completion initiatives to increase postsecondary enrollment.**
  - Automatic WCG income eligibility for students receiving the following public benefit programs, or for students whose parent is receiving, while in grade 10, 11, or 12.
    - Aged, blind, or disabled assistance benefits
    - Essential Needs and Housing Support Benefits
    - Pregnant Women Assistance Program
- State Financial Aid Workgroup engagement



# 2022 Session Update – Financial Aid Related Legislation

- **2SHB 1835 – Creating outreach and completion initiatives to increase postsecondary enrollment.**
  - Promotion of Washington College Grant and FAFSA/WASFA
    - WSAC shall conduct a statewide advertising campaign to increase awareness of WCG.
    - SBCTC will administer pilot program and award grants to CTCs to provide outreach specialists to boost FAFSA and WASFA completion rates.
    - State library will administer a grant pilot program to increase FAFSA/WASFA filing rates.
    - WSAC will collaborate and share data with DSHS to increase awareness and usage of WCG.

# 2022 Session Update – Financial Aid Related Legislation

- **HB 1907 – Gift Equity Policies** (does not apply to community and technical colleges)
  - Institutions cannot reduce federal, state or institutional aid due to receipt of private scholarship if unmet need.

# 2022 Session Update – Financial Aid Related Legislation

- **HB 2007 – Establishing a nurse educator loan repayment program under the Washington health corps.**
  - Nurse educators teaching for approved nursing programs is now added under the Washington Health Corps umbrella.
  - WSAC shall consult with planning committee to design.

# 2022 Session Update – Financial Aid Related Legislation

- **E2SSB 5600 – Concerning the sustainability and expansion of state registered apprenticeship programs.**
  - Expands opportunities for apprenticeships (not specific to state financial aid).
- **E2SSB 5764 – Washington College Grant for Apprenticeship**
  - Changes WCG-A maximum award value to align with CTC WCG award.
  - Apprentices doing RSI at CTC, to receive WCG-A via college by 2025-26.
  - Study by Ruckelshaus Center – final report due in 2026.

# 2022 Session Update – Financial Aid Related Legislation

- **2SSB 5789 – Creating the Washington career and college pathways innovation challenge program.**
  - WSAC received \$6 M for FY 2022-23, for the Career & College Pathways Innovations Challenge Program.
    - WSAC will award competitive **Regional Challenge Grants**\* to support local or regional partnerships among K-12, colleges, and community-based organizations.
  - Grantees will seek to:
    - Implement or expand interventions to increase college enrollment and completion.
    - Support high school students or adult learners.
    - Eliminate opportunity gaps for marginalized populations.

# 2022 Session Update – Residency Related Legislation

- **ESSB 5874** – Concerning residency of students affiliated with the military. **NOT** state aid eligible.
  - Modified Residency for active duty military members, National Guard, reservists, and their dependents.
- **ESSB 5874** Clarifies that students must live in Washington for a period of one year **prior to enrollment in higher education**.
  - **WASFA will be updated accordingly.**

# 2022 Session Update – Residency Related Legislation

**ESSB 5874 further clarifies residency change from 2021-22**

Live in WA for 1 year immediately before first term.



The Washington residency must be for purposes other than college. If you take any courses at another Washington college during the prior 12 months, you cannot have taken more than 6 credits in any given term. If you exceed that limit you must prove that you have a Washington residence for non-college reasons.

# 2022 Session Update – Financial Aid Related Legislation

- **ESSB 5847 – Providing info to public service employees about the public service loan forgiveness (PSLF) program.**
  - Student Loan Advocate (SLA) shall develop and update annually, materials, such as FAQs, designed to increase public awareness of PSLF program.
  - SLA will coordinate with OFM, secretary of state, and local government entities to ensure materials are received by employers.
  - OFM shall develop a program for state agencies to certify employment for purposes of the PSLF program.

# 2022 Session Update – Financial Aid Related Legislation

- **SHB 1805 – Concerning the opportunity scholarship program.**
  - Expands the MFI range beyond 125 percent if student can demonstrate financial need and to remain eligible they must meet SAP.
  - Adds apprenticeship programs as an option. Aligning program definitions with WCG in "resident student," "eligibility time frame," and "SAP."
  - Expands definition of eligible county and eligible school district, again adding apprenticeship to the enrollment option.

# 2022 Session Update – Financial Aid Related Legislation

- **SB 5545 – Concerning survivor benefits.**
  - A surviving spouse or surviving domestic partner of the eligible veteran or national guard member has 10 years to receive tuition waiver benefits under the waiver from the last recurring event: date of death; date of total disability; federal determination of service-connected death or total disability; or federal determination of POW or missing in action status.



# Revisiting 2021 – WAVE (funded through budget)

## The Washington Award for Vocational Excellence (WAVE) Scholarship relaunched in spring 2022.

- Administered in partnership with the Workforce Training Board (WTB) and WSAC.
- Awardees are being selected via the WTB process.
- WSAC will be disbursing funds starting Fall 2022.

# Revisiting 2020

- **Undocumented Student Loan Program - SB 6561 (2020)**
  - Contingent on private donations that would be matched with state funds up to \$2M/biennium. Private funding has not been secured.
- **Expanding Access to Higher Education SB 6141 (2020)**
  - WSAC to develop consistent definitions for financial aid awards (Section 3)
    - Estimated implementation for 2023-24 award notifications
    - WSAC financial aid workgroup engagement

# Washington Bridge Grant

The Washington Bridge Grant is an annual stipend awarded in addition to WCG for students who are not CBS eligible.

- To provide supplementary financial support to low-income students to cover higher education expenses beyond tuition and fees.



# Washington Bridge Grant

- **Only for 2022-23 award year**
  - ESSB 5693 (Budget Bill) – This program was created by a proviso in the budget.
  - The Legislature would need to take action for it to be effective beyond this year.
    - Step towards acknowledging that there are more costs associated with attending college than just tuition.





# Washington Bridge Grant

- **Maximum annual award amount is \$500**
  - Disbursed as either a lump sum payment or may be disbursed over enrolled terms.
  - Each institution will determine which is in the best interest of the student.
  - Award amount may be less - based on student need.



# Washington Bridge Grant

- **Who is eligible to receive the WA Bridge Grant?**
  - Students who receive a maximum Washington College Grant award and still have need remaining;
    - 0-60% MFI
  - Are enrolled in at least three credits at an eligible institution;
  - Meet satisfactory academic progress.



# Washington Bridge Grant

- College Bound Scholarship eligible students **are not** eligible to receive the Washington Bridge Grant.
  - Please refer to “CBS Eligibility Cruncher” to determine eligibility.

## Please note:

- Students who signed up for CBS, but did not meet the high school graduation requirement, did not meet the enrollment deadline, and those who are past the 5-year eligibility, would be considered for Bridge Grant. (These students are not currently meeting CBS eligibility.)

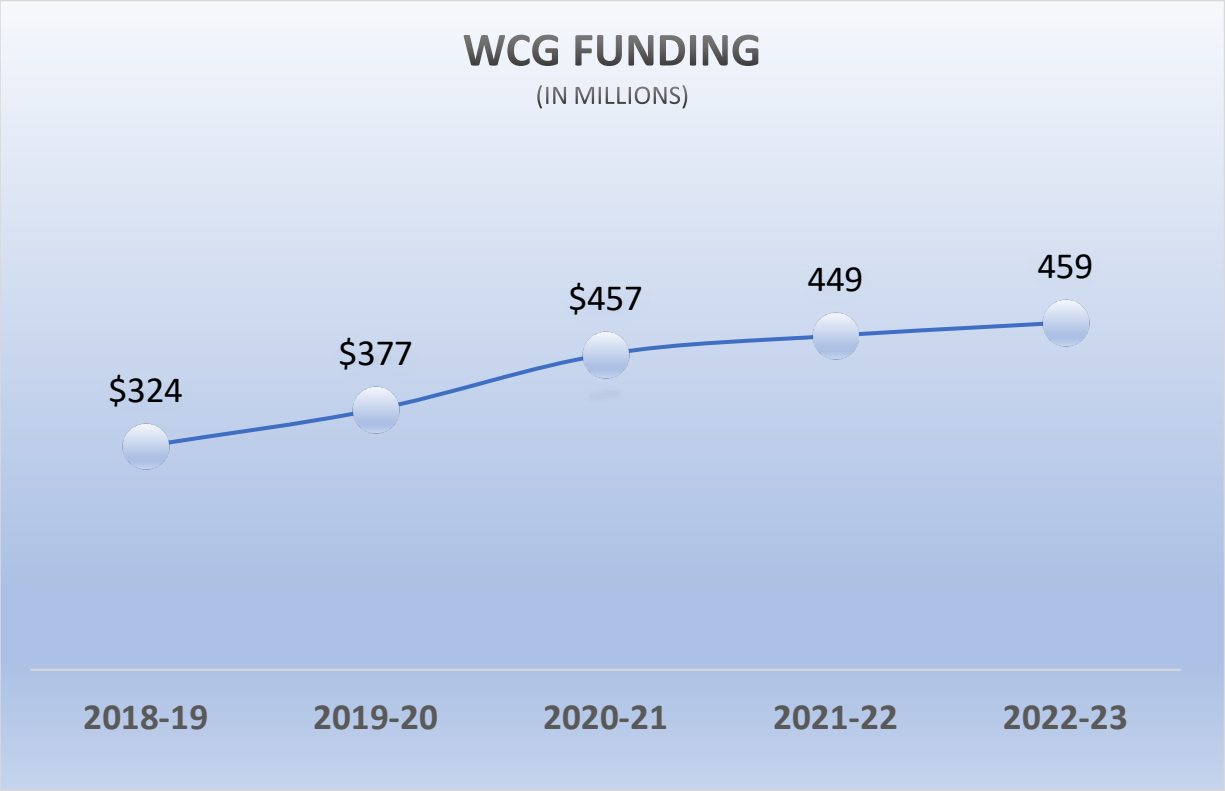

# Washington College Grant: Award Amounts

**Maximum award amounts for public institutions cover full tuition and fees.**

- Must be awarded for all terms a student is enrolled and eligible.
- Award amount is prorated based on income eligibility (MFI level) and enrollment level.
- Cannot exceed need.

# CBS and WCG




## CBS eligible students receive WCG

- Provides additional funding for a small book allowance.
- CBS awards are not prorated based on income level for eligible students up to 65% MFI.
- CBS eligible students receive funding up to 65% MFI and are eligible for WCG up to 100% MFI.
- College Bound Scholarship eligible students **cannot** receive the Washington Bridge Grant.

# WCG – Operational Considerations

- **Reporting will continue quarterly.**
  - Need ongoing updates for forecasting costs – including projected awards and payments requested timely
- **2022-23 funding and reporting will continue like presently done.**
- **Timely, reconciled data from colleges is critical.**

Due Date: July 11, 2022

- Includes reconciled data.
- Funds due to or due from the colleges/WSAC.
- Funds for the new year may not be drawn until all funds are reconciled/returned for your specific college and Participation Agreement renewals are approved.

# National Guard Grant

## New for 2022-2023

- SHB 1642
  - The maximum award value calculation changes for 2022-23. Maximum award value cannot exceed Washington College Grant maximum award, plus \$500 for books and supplies.
    - Will likely set max under statutory authority, as demand likely to exceed appropriation.
  - Allows graduate students to participate in the program.



# Educator Workforce Awards for AY 2022-23

- Student Teaching Grant and Teacher Shortage Conditional Scholarships Application cycle is twice a year.
- Last cycle for awards opened April 4, and closed April 29.
- Applicants can apply for both programs with the same application.

# 2022-23 SWS Operational Updates

## **As a result of the 2022 Legislative Session:**

- SWS Appropriation remains at \$7.8 million.
- No changes to legislatively-directed employer matching requirements or SWS reimbursement rates.
- Continued focus on improving alignment between SWS and public assistance programs, like the Basic Food program otherwise known as SNAP.

# SWS & COVID-19 Emergency

## **2022-23 Emergency SWS Program Guidance Expiring**

- The emergency rule enacted in 2020 that enabled institutions to reclassify state work study awards as general financial aid is expiring.
- Schools for whom the Summer term is the last term of the 2021-22 academic year may continue following the emergency guidance through the end of that term.

## 2020-21 SWS Expenditure Profile

- Just under \$9 million in gross earnings; over \$2.5 million in employer match.
- 2,849 students earned an average of \$3,110 in SWS dollars.
  - 36% earned by students attending public four-years
  - 27% earned by students attending private four-years
  - 37% earned by students attending public two-years
- 88% of gross SWS earnings earned on-campus, 12% earned off-campus.
- 87% earned by undergraduate students, 8% by graduates.

# Current SWS Status

- SWS earnings for the current 2021-22 year are below 2020-21 earnings.
- Overall, SWS expenditures are almost 8% below from 2020-21 levels.

# 2022-23 Renewal Process

- Deadline for submission is week of June 15.
- WSAC seeks to make renewal determinations for all institutions prior to 7/1/22, but institutions approved after this date are approved retroactively to 7/1/22.

# Student Access to SNAP Benefits

- National research indicates nearly 3 in 5 college students have experienced basic needs insecurity since the pandemic.
  - Encourage colleges to provide proactive communication to students who are likely to be eligible for Washington Basic Food/SNAP.
  - WSAC has provided a template letter for students with a \$0 EFC and/or a Work Study award or eligibility.

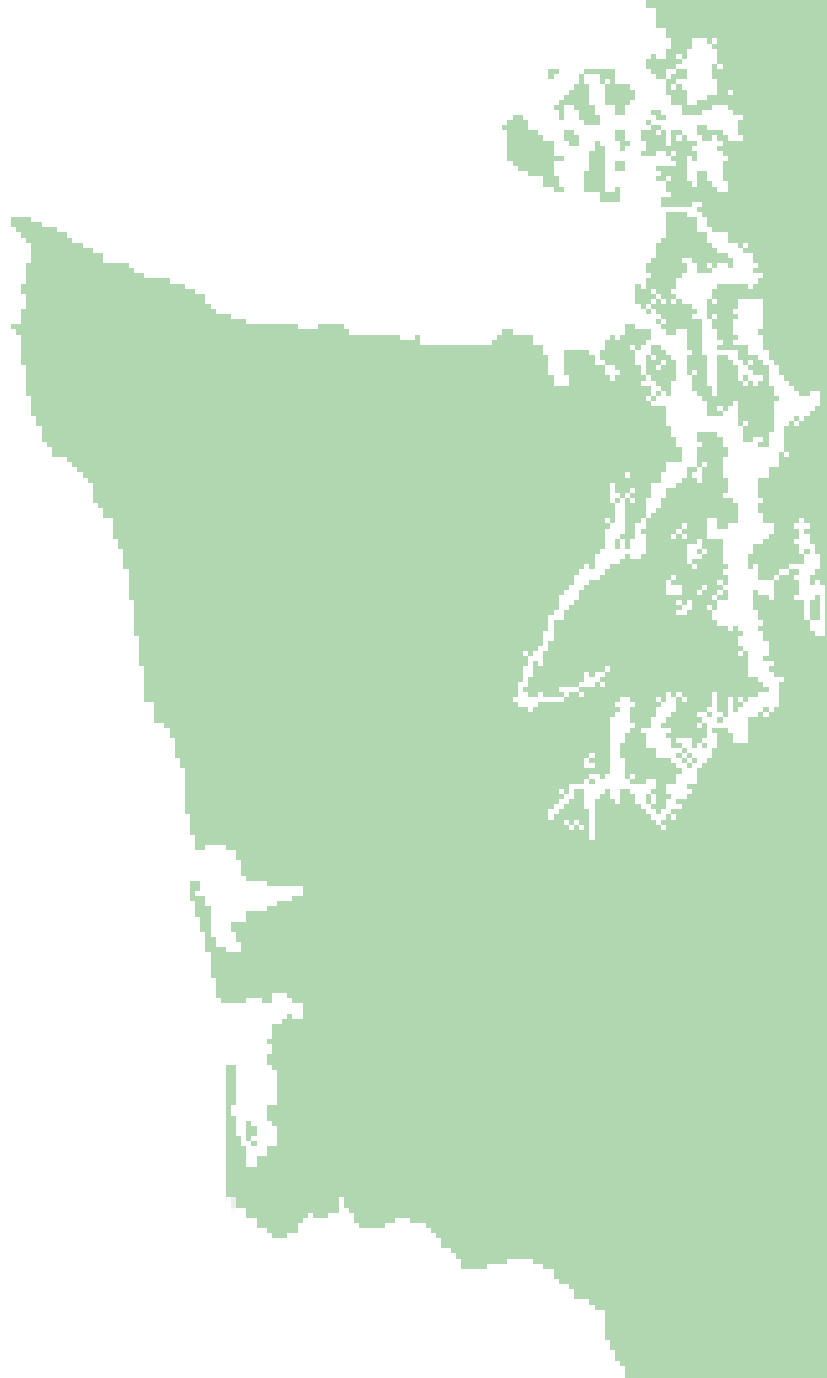
