### **Presentation and Discussion: Board Governance Workgroup**

- The workgroup met three times to develop draft bylaws for the Board to approve. Until now, the Board has never had formal bylaws.
- Joel reviewed each section of the draft bylaws for Board members. Key sections include:
  - Section 4: Board Co-chairs. While both Co-chairs will hold their positions for one-year terms, it is the intent of the Board that Co-chairs will serve at least two consecutive one-year terms.
  - Section 7: Ad Hoc Advisory Committees. The Board will create a legislative advisory committee each year to prepare recommendations for the ensuing legislative session and remain active through the end of that session.
  - Section 10: Voting Procedures. All Board members, including legislators, have voting rights.
- Board members provided feedback on the draft bylaws for future consideration.

- It may be beneficial to select Co-chairs a year in advance of their terms so that they have additional time to transition into their roles.
  - WSAC's Assistant Attorney General confirmed that the draft bylaws may not conflict with the Board's statute, [RCW 28B.77.310](#).

## Presentation: WSIPP Study on Guided Pathways

- Julia provided an overview of the Washington State Institute for Public Policy (WSIPP)'s ongoing evaluation of Guided Pathways (GP), a whole-college reform framework designed to help students in community and technical colleges (CTCs) choose academic paths and earn credentials or transfer on time.
- In 2021 the Legislature passed [SB 5194](#), directing WSIPP to conduct an evaluation of the implementation of GP in Washington, identify evidence of its effectiveness, and examine student outcomes.
- WSIPP asked all 34 CTCs to respond to a survey about GP implementation that included questions framed around four legislative requirement areas: mapping educational pathways, advising and career counseling, data analysis, and student support services.
  - 33 CTCs responded. All of them were implementing GP to some extent.
- GP has increased collaboration between CTC staff, faculty, and advisors; improved equity; and contributed to positive culture changes on CTC campuses.
- Challenge areas for GP have included COVID-19-related implementation problems; staff capacity and turnover; CTC-wide changes to their data system, ctclink; and program buy-in.
- Between 2012 and 2019 (prior to the COVID-19 pandemic):
  - Rates of first-year retention increased similarly at both GP and non-GP CTCs.
  - Rates of first-year course completion (English and Math) increased similarly at both GP and non-GP CTCs.
  - Rates of first-year credit accumulation increased similarly at both GP and non-GP CTCs.
  - Average GPAs increased similarly at both GP and non-GP CTCs.
- WSIPP's final report on GP is due to the Legislature in December 2029.

The bill draft below makes the following changes to the Board's statute, RCW 28B.77.310 (with all amendatory language highlighted):

- Extends Co-chairs' term lengths from one to two years.
- Requires the Board to elect Co-chairs biennially instead of annually.
- Allows the Board to meet more than four times a year.
- Requires the Board to consult data from WSAC instead of WTB and eliminates the requirement for WTB to maintain a public-facing WEIAOB data dashboard.
- Changes the annual due date for the Board's legislative report to December 31 from August 1.
