Summer 1 Awards

As a follow-up to the email below, we wanted to address the question of how to manage students who were awarded CBS during Summer 1 term in CSAW who do not meet the six-year eligibility time limit, before the CBS updates described below.

Students awarded for the Summer 1 term in CSAW and whose funds have been requested/paid in the WSAC portal prior to the CBS Eligibility Checker updates that occurred on August 12th will be allowed to keep the CBS funds for the Summer 1 term only. Please cancel any future CBS awards for ineligible students, as well as Summer 1 awards whose funds were never requested.

Managing CSAW Edit

Students will have the “Student not eligible for CBS” edit for the Summer 1 term. We have recently updated this edit to be overridable. Please override with “Per 8/2025 WSAC Guidance”.

Hello Colleagues!

We wanted to provide some updated information about the CBS Eligibility Checker and College Bound (CBS) policy. **Please note:** CBS Eligibility Checker records will be fully reprocessed

overnight. Do not rely on the Checker information until tomorrow. These changes reflect recent legislation and program updates that take effect in the 2025–26 academic year:

Rules Regarding College Credits Before High School Graduation

Students must enroll in college within one year of high school graduation to meet the enrollment deadline for College Bound.

- Effective July 1, 2025, credits earned before high school graduation (ex: Running Start/College in High School) do not meet the one-year enrollment deadline. Enrollment must be after high school graduation to meet the enrollment deadline.
- **Reminder:** Students will be considered to have enrolled upon earning credit(s) for the term or receiving the first scholarship disbursement, whichever comes first.

High School Equivalency (GED, etc.)

[SB5543](#): Eligibility expanded for CBS to students who have received a high school equivalency certificate as defined in RCW [28B.50.536](#).

Effective July 27, 2025, students who meet the following criteria will fulfill the graduation and 2.0 GPA requirements for College Bound:

1. Earned a high school equivalency certificate (example: GED) before their 21st birthday.
2. Enroll no later than the fall term, as defined by the institution of higher education, one academic year following high school graduation or high school equivalency completion.
3. Completed the high school equivalency in Washington State.
4. Submit a [GED Transcript](#) to their institution for verification.

Schools may **manually override** the student's record to reflect GED completion as their valid HS/GED Grad Year.

Six-Year Eligibility Time Frame

5785-S.PL: Beginning in 2025-26, CBS awards must be used within six years of receipt, and students still must enroll within one year of high school graduation.

- The CBS Eligibility Checker has been updated to calculate the six-year eligibility time limit.

- If a student is still within their six-year eligibility, they will have a **“Yes”** in the Elig. Open column. For those who are not, they will have a **“No”**.
- The CBS Eligibility Checker evaluates when a student first enrolled based on CSAW reporting, and whether they have or will meet the Enrolled by Deadline.

CBS Eligibility Checker File Output

There have been two changes to the verbiage of the CBS Eligibility Checker output file:

- **"HSGradYear"** is now **"HSorGEDGradYear"**
- **"FiveYearEligibilityWindowOpen"** is now **"EligibilityWindowOpen"**

The **2025–26 Program Manual** will be updated to include these changes. We'll notify the community once the updated manual is available.
