<u>Good Jobs Challenge – U.S. Department of Commerce Grant</u> Heather Hudson, Director of Policy & Planning, Washington Student Achievement Council

WSAC is the lead agency for a recent grant awarded by the United States Department of Commerce Economic Development Administration (EDA). EDA's American Rescue Plan Good Jobs Challenge (GJC) is making once-in-a-generation investments in high-quality, locally led workforce systems to dramatically transform America's communities. With a focus on equity, the program is expanding career opportunities for more Americans to reach their full potential and secure good-paying jobs while producing a skilled workforce to ensure the United States is prepared to innovate, compete, and succeed in a 21st Century global economy.

GJC highlights workforce development as key to accelerating local economic growth and rebuilding regional economies, so they are more resilient to future challenges while providing good job opportunities for American workers to achieve economic mobility and security. The work of the grant engages WSAC in collaboration with Career Connect Washington and a coalition of industry, labor, education, and community leaders to create good jobs and provide economic opportunities for residents in Washington State.

Apprenticeship Building America\_will expand registered apprenticeship and recognized pre-apprenticeship programs in these high-demand industries: advanced manufacturing and aerospace, agriculture and natural resources, clean technology and energy, construction, education, finance, healthcare, information technology and cybersecurity, life sciences, and maritime.

The Employment Security Department, the Department of Labor & Industries, the Workforce Training & Education Coordinating Board, the Washington Student Achievement Council, and other Career Connect Washington partner agencies will work closely with the apprenticeship community and CCW Program Builders to:

- Increase the number of registered apprenticeship and recognized preapprenticeship programs in target industries;
- Create or expand 22 registered apprenticeship programs to benefit 300 apprentices;
- Create or expand 11 recognized pre-apprenticeship programs to benefit 400 preapprentices;
- Increase the diversity of apprentices and pre-apprentices;
- Promote equitable access to high-quality careers for communities furthest from opportunity; and
- Increase employer awareness of and commitment to programs by enlisting 48 new employer sponsors.

#### **Nursing Education and Workforce Progress and Needs**

The Governor and legislature made considerable investments in nursing and nursing education in the past two years. Ms. Meyer describes the investment amounts and progress in fulfilling the actions. These include nursing education faculty salaries, grants to nurses precepting student nurses, the LPN apprenticeship pathway, increased enrollments in nursing programs, and use of simulation in nursing education.
