WSU Notes:

In Pullman only, additional fees include Student Recreation Center, Health, Transit, and CUB fee which total \$847 for all groups except Distance Degree Programs. Resident and nonresident undergraduates also pay an additional \$50 for the stadium for a total of \$897. **In Spokane only**, the mandatory health fee is \$156.

Master of Business Administration rate is for only the Pullman campus. Students enrolled in the MBA programs at WSU Tri-Cities and WSU Vancouver, as well as students completing the legacy MBA program in Pullman, will continue to pay the regular graduate student tuition rate.

Students continually enrolled in the Masters of Nursing program since 2004-2005 academic year pay a lower transitional rate as they complete their programs. For 2010-2011 annual building + operating rates are \$11,770 for resident students and \$26,800 for non-resident students.

WWAMI. Under a memorandum of understanding (MOU) between WSU and UW, students attending the first year of medical school in Seattle, Pullman, or Spokane will pay the same total tuition and enrollment fees. These rates are set by the University of Washington for the medical school. Other mandatory fees are assessed based on the specific campus where the student is enrolled.

General & Institution Specific Notes:

Tuition and fee rates reflect those reported by institutions.

CWU additional mandatory fees for 2010-11 include an athletic fee, a recreation center fee, a student health and counseling center fee, and a student union fee. The fees are standard across all categories and total \$828 per year.

EWU additional mandatory fees for 2010-11 include a transportation fee, a recreation center fee, and a comprehensive health and wellness fee. The fees are standard across all categories and total \$437 per year.

TESC additional mandatory fees for 2010-11 include health and counseling fees, a bus pass fee, clean energy fee, and CAB building fee. A student taking fifteen credit hours per quarter for 3 quarters would pay about \$536 per year.

WWU additional mandatory fees include a health service fee, non-academic building fee, renewable energy fee levied on a per credit basis to a maximum of 10 credit hours per quarter, a student recreation fee and a transportation fee. These fees are standard across all categories and total \$702 per year.

Community college tuition and fee rates are based on 15 credit hours per quarter for 3 quarters. The tuition figure above reflects the maximum S&A fee. Other fees, including technology fees vary by school.
