- 2SHB 1835 (2022) allows for automatic WCG income eligibility for students receiving any of the following public benefit programs:
 - Aged, blind, or disabled assistance (ABD) benefits
 - Essential needs and housing support program (HEN) benefits
 - Pregnant women assistance program (PWA) financial grants
- WSAC is currently reviewing other public benefit programs and may expand this list this summer.



- The goal of 2SHB 1835 is to help connect students to higher education and to remove barriers to paying for college.
- Students who meet eligibility under this category are referred to being eligible under the Washington College Grant – Connect (WCG-C).
- Program is still WCG, just a different way to qualify.
- Effective July 1, 2023, for the 2023-24 Academic Year.



Awarding students WCG under WCG-Connect:

- Must meet residency and all program requirements
- FAFSA or WASFA not required
 - May require coordination with other offices on your campus
- Qualify for maximum WCG award
- Qualify for WA Bridge Grant





- WCG-C students who filed FAFSA or WASFA
 - Must be awarded maximum WCG even if MFI is over 65%
 - Awards will need to be adjusted
 - Award WA Bridge Grant
- Awarding students CBS and/or PTC
 - Must have a FAFSA or WASFA
 - MFI must be met and is not included under WCG-Connect
 - CBS students not eligible to receive the WA Bridge Grant



- WSAC has built the WCG-C
 Eligibility Checker as a way for schools to identify their students.
- To access the Eligibility Checker, log into the Portal and go to Home > Programs > WCG-Connect.
- Click on Eligibility Checker.




The last way is to upload a .txt or .csv file of SSNs

Once a search has been executed, you will be able to see the following information for your students.



If the student is in CSAW, you can click on their WCG QER to go to their student detail information.



In the student detail, WCG-C students will have "Eligible under WCG-C" indicated.

Hover over this to view the eligible years.

Click on the link to go back to the Eligibility Checker for that student.






- CSAW has been updated to recognize WCG-C eligible students.
 - There will be no edits for WCG-C students that are awarded with max WCG and Bridge.
- If a WCG-C student has no WASFA or FAFSA information, there will be no information (including MFI).

If there is no WASFA or FAFSA on file and a student has CBS or PTC awarded, there will be edits to stop funds from being requested. The example below is for a CBS student that is WCG-C eligible but does not have a FAFSA or WASFA, but school awarded CBS.





Another important thing to remember is that WCG-C eligible students must receive the maximum amount of WCG and WA Bridge award, regardless of their MFI.


- If a student self-identifies that they are WCG-C eligible, but is not in the eligibility checker, schools will need to collect documentation of their eligibility from their program and let WSAC know by emailing the WCG team through secure messaging in the portal.
- Please attach/include the following:
 - Any documentation of their approval
 - Name
 - DOB
 - Client ID
 - SSN



- The WCG-Connect Eligibility Checker will identify which students are eligible.
- ✓ WCG-C is not a different fund, but a different way for students to qualify for Washington College Grant (WCG).
- Students are eligible for maximum WCG, regardless of their MFI or if they have filed a WASFA or FAFSA.
- Students can receive WCG and Bridge without a WASFA or FAFSA on file, but they cannot receive CBS or PTC.
