




# Why a coordinated survey in Washington?

- Institutional, regional and state level data to drive larger-scale change
- Understanding prevalence and resource use/barriers to use
- Comparable data with the same instrument and institutions can have the data for further analysis and institutional/regional insights
- A Washington instrument serving Washington institutions over time for learning, planning and advocacy.

#### Postsecondary students' basic needs are not being met.

Key findings from the fall 2022 basic needs insecurity state survey:

- 1 in 2 students reported experiencing either food or housing insecurity or homelessness
- High basic needs insecurity in all regions of the state and in CTCs and baccalaureate institutions.
- **Higher insecurity for certain groups** like former foster care students and parenting students
- Less than half of students experiencing insecurity accessed basic needs support resources in the prior 6 months.

#### Postsecondary Basic Needs Act (2SHB 1559 2023) requirement:

By the beginning of the 2024-25 academic year, the Washington student achievement council must collect and disseminate results of a student survey developed by the student achievement council, in collaboration with the state board for community and technical colleges and an organization representing the presidents of the public four-year institutions of higher education, to assess food security, housing security, and access to basic economic supports. Results from the survey may be used by the institutions of higher education and the tribal college. Existing survey tools may be used for this purpose.<sup>[1]</sup>

In addition, the statute for the *Supporting Students Experiencing Homelessness* grant program <u>ESSB 5702</u> (2023) also requires institutions to do annual census surveying on students' food and housing insecurity, and this state survey fulfills this requirement.

# **Process: How will the survey be administered?**

- Substantially similar to 2022 instrument
- 25-30 items (depending on responses)
- Items focus on food security, housing security, healthcare access, resource use, and limited demographics
- Changes reflect change in methodology collecting demographic data directly vs. matching responses to institutional demographic data
- Expanded questions around childcare access/needs



- Participating institutions provide data to WWU (student emails + key demographics)
- WWU administers survey to students via email (with a 'from' address from your institution/SBCTC) with weekly reminders
- Institutions promote survey participation to students ('check your email' campaigns, survey stations, etc.)
- WWU matches survey responses to demographic data provided by institutions for analysis
- WWU returns datasets for respondents enrolled at each institution for further analysis at the local level

Jan 2025	Findings report distributed
Nov 22, 2024	Survey closes for responses
October 28, 2024	Survey distributed
October 21, 2024	Student datasets submitted to WWU
September 30, 2024	DSAs w/WWU finalized
July 2024	IRB review completed
May - July 2024	Confirmed administration plan, survey instrument, protocols, data sharing
Winter and Spring 2024	Engagement with stakeholders on survey plan

# How can we increase awareness and promote survey participation?



#### Challenge:

Low survey response rates will affect data usefulness, especially at the local and regional levels.

#### **Strategies:**

- Institutional Communication: templates and timeline to be provided by WSAC/SBCTC
- Awareness events (ex tabling with computers available, mention at other large events)
- **Public messaging** (Reader boards, portal announcements, texting, social media)
- Partnership with student leadership, faculty to encourage participation



#### **Outreach Timeline:**

- Email with survey will be sent to enrolled students 10/28. Students who haven't responded will receive follow up email invitations to participate 11/04, 11/11, and 11/18.
  - Institutional messages can be timed to amplify

#### **Outreach messages:**

- Templates will be available by end of September
- Who sends messages? Leadership, Student Affairs

  - Student Services/Affairs: Promote survey awareness and participation
- November:
  - Promote survey awareness and participation with students
  - Survey closes 11/22
